

## Extract from Resolution No. 20/2018 of the CEO of the Budapest Stock Exchange Ltd

Budapest, 15 January 2018

The Chief Executive Officer of the Budapest Stock Exchange (hereinafter: Exchange) declares that in case of **SET GROUP Pic.** (ISIN: HU0000107537, registered seat: 1023 Budapest, Rómer Flóris u. 55.) all open orders will be cancelled on 15<sup>th</sup> of January 2018 during the end of day batch process. On 16<sup>th</sup> of January 2018, the trading of SET GROUP shares starts with empty order book.

## **Explanatory note**

According to Section 3.2. b.) of the General Terms of Service of the Exchange, Book Five - Regulations on Trading, the CEO is entitled to decide on the deletion of orders when the trading model is changed.

The reason of the deletion of the orders is that the applied trading model is changed from "Auction Trading Model" to "Continuous Trading with Auctions Trading Model".

In consideration of the above, the CEO of the Exchange decided in accordance with the dispositional part of this resolution.
