



**Resolution No. 359/2018. of the Chief Executive Officer  
of the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends** the exchange trading of the securities named **Erste Henry Hub Turbo Short 41 Warrant**, ticker symbol: **EBHENHUBTS41**, ISIN code: AT0000A22LD0, issued by **Erste Group Bank AG** (Am Belvedere 1., A-1010 Wien, Austria) (hereinafter referred to as 'Issuer') **on November 13, 2018, from 1:21 p.m. for the remainder of the Exchange Day** and **remove the securities from the Product List** at the request of the Issuer.
