



## EXTRAORDINARY ANNOUNCEMENT

Appeninn Vagyonkezelő Holding Nyilvánosan Működő Részvénytársaság (registered seat: 59 Andrássy Street, HU-1062 Budapest, company registration number: 01-10-046538; hereinafter as: 'Company') respectfully informs the Market that the transaction under the agreement concluded between KONZUM PE Magántőkealap (registered seat: 59 Andrássy Street, HU-1062 Budapest; MNB registration number: 6122-44, managed by: Konzum Befektetési Alapkezelő Zártkörűen Működő Részvénytársaság /registered seat: 1062 Budapest, Andrássy út 59.; company registration number: 01-10-045654/) as seller and BDPST Ingatlanforgalmazó és Beruházó Zártkörűen Működő Részvénytársaság (registered seat: 27 Kelenhegyi Street, HU-1118 Budapest., company registration number: 01-10-048550; hereinafter: 'BDPST Zrt.') as buyer, for the purchase of 9,755,567, namely nine million seven hundred fifty-five thousand five hundred sixty-seven pieces of Appeninn shares (hereinafter: 'Shares'), issued by the Company – mentioned in the extraordinary announcement¹ published by the Company on 23rd August 2018 – has been closed on the present day.

As the result of the above transaction the numbers of Appeninn shares to which voting rights are attached, held <u>directly by the KONZUM PE Magántőkealap</u> decreased from of 10,144,567, namely ten million, one hundred forty-four thousand, five hundred sixty-seven to 389,000, namely three hundred eighty-nine thousand pieces, consequently the ratio of KONZUM PE Magántőkealap in the Company decreased from 21.41% to 0,82%, crossing the threshold of 20, 15, 10 and 5% mentioned in Subsection (3) of Section 61 of Act of CXX of 2001 on the Capital Market (hereinafter: '*Tpt.*'), while the numbers of Appeninn shares to which voting rights are attached, held <u>directly by BDPST Zrt.</u> rised from 0, namelyzero to 755,567, namely nine million seven hundred fifty-five thousand five hundred sixty-seven pieces, consequently the ratio of BDPST Zrt. in the Company rised from 0% to 20,59% crossing the threshold of 5, 10, 15 and 20% mentioned in Subsection (3) of Section 61 of Tpt.
