



Extract from Resolution No. 36/2020 of the Chief Executive Officer of the Budapest Stock Exchange Ltd.

Budapest, February 13, 2020

The CEO of the Budapest Stock Exchange Ltd. passes the following decision on single equity based ELMŰ and ÉMÁSZ futures contracts regarding the delisting of their underlying product in the near future.

The CEO sets February 18, 2020 as the Last Trading Day in certain maturities of the ELMŰ and ÉMÁSZ futures contracts.

The CEO sets February 21, 2020 as the day of removing the above contracts from the Product List.

Reasons

Upon authorization by Section 34.2. of the Book Five of the “General Terms of Service of the Budapest Stock Exchange Ltd.” titled Regulations on Trading, the Conciliation Committee set February 18, 2020 as the Last Trading Day in certain maturities of the ÉLMŰ and ÉMÁSZ futures contracts.

At the same time, considering the stipulation contained in Section 32.2. b) of Book Two of the “General Terms of Service of the Budapest Stock Exchange Ltd”. titled Regulations on Listing and Continued Trading (hereinafter: ‘Regulations on Listing’), the Conciliation Committee set February 21, 2020 as the day of removing the above contract from the Product List.

Based on Section 32.2. a) of Regulations on Listing, the CEO has the power to issue decisions on delisting Exchange Products and removing them from the Product List.
