



## Extraordinary Announcement of 4iG Plc.

Transactions regarding 4iG shares owned by persons  
closely associated with executive officers

4iG Public Limited Company ("4iG"), in accordance with the provision of Subsection (2) Section 55 of Act CXX of 2001 on the capital market hereby informs the participants of the capital market, that **Bartolomeu Investments Kft.** (registered seat: 2. Floor, 5 Vörösmarty Square, Budapest, HU-1051; company registration number: Cg. 01-09-347440; "Bartolomeu") contributed its 17,104,822 4iG shares issued by 4iG into **Bartolomeu ICT Kft.** (registered seat: 2. Floor, 5 Vörösmarty Square, Budapest, HU-1051; company registration number: 01-09-416561; "Bartolomeu ICT") a 100% subsidiary of Bartolomeu, in the framework of an over-the-counter transaction (OTC) at an average price (contribution value) of HUF 656.6513 per share (the "Contribution"). The share transfer of the 4iG shares related to the Contribution has been launched, as set out in the 4iG Extraordinary Announcement published on 27 October 2023<sup>1</sup>, and has been closed today, November 03 2023, such 4iG shares have been credited on the security account of Bartolomeu ICT. The share transfer took several working days due to technical banking circumstances and the volume of the Contribution.

As a result of the Contribution, the number of 4iG shares directly owned by Bartolomeu changed from 17,104,822 to 0 pieces, by which his share of ownership changed from 5.72% to 0.00%, thus his voting rights in 4iG decreased from 5.81% to 0.00%, on the other hand, the number of 4iG shares directly owned by Bartolomeu ICT changed from 0 to 17,104,822 pieces, by which its share of ownership changed from 0.00% to 5.72%, thus its voting rights in 4iG increased from 0.00% to 5.81%, therefore crossing the threshold of 5% mentioned in Subsection (3) of Section 61 of Act of CXX of 2001 on the Capital Market.

As a result of the Contribution, the indirect influence of Pedro Vargas Santos David over 4iG, as the indirect owner of Bartolomeu and Bartolomeu ICT, as well as the Member of the Board of Directors (executive officer) of 4iG, has remained unchanged.

Based on the shareholder's announcement received on the present day, the ratio concerning the shares and voting rights of the shareholders with more than 5% ownership has changed as follows.
